Juvenile court representative

Youth help in criminal procedure



You have a conflict with the law – what now?

- **We are contact person for**
 - youth in the age of 14 until 17 years and
 - in the age of 18 until 20 years,
for which a criminal proceeding has been instituted.
- **We accompany and advise**
youth and adolescents through the whole criminal proceeding and want to offer a help to young people and their parents if they need it.
- **Our help is**
 - generally free,
 - voluntary for the young person,
 - legitimated in the code of social law and the law of juvenile court law.

Offer of the juvenile court representative

- **We inform about**
 - the commencement of proceedings,
 - a cessation of proceeding,
 - the sequence of proceeding.
- **We advise at**
 - incertitude and insecurity concerning the proceeding,
 - at problems and conflicts in family, school, apprenticeship, place of employment, friends.
- **We accompany you if you wish it**
to the court trial and inform about the development, life situation, social environment and the future plans and provide a juvenile court report.
- **We provide**
suggestions and measures as deciding help for the court and the prosecution.
- **We conciliate/control**
 - social skills training,
 - read instead social hour,
 - road safety education.

Information

- The juvenile court representative gets still an information, if the youth or the adolescent has committed a crime or shall have committed a crime.
- The juvenile court representative is composed of a team of social workers, which are independent in their work from the court trial and the police.

Important for the parents

- We are prepared to advise your daughter or your son during the whole proceeding. It is important for us to talk with you.
- If we have got to know your daughter or your son by conversations, we can make the prosecutor or the judge of the juvenile court a proposition, how the proceeding can be concluded.
